**PETITION NO. 1346** - The Connecticut Light and Power Company d/b/a Eversource Energy declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the replacement and relocation of an existing telecommunications facility and an existing relay and control enclosure located at Manchester Substation, 250 Olcott Street, Manchester, Connecticut, and related substation improvements.

Dear Ms. Bellion:

The Connecticut Siting Council (Council) is in receipt of your email correspondence of July 3, 2019 regarding temporary changes to work hours for the above-referenced declaratory ruling issued by the Council on July 20, 2018.

Pursuant to Condition No. 1 of the Council's Decision of July 20, 2018, your request to perform work from 7:00 p.m. to 10:00 p.m. on Monday, July 8, 2019 and Tuesday, July 9, 2019 is hereby approved. The extended hours are necessary to complete an extended concrete pour for the control enclosure. If the concrete pour cannot be performed on July 8, 2019 due to weather, it will be performed on July 9, 2019. Construction equipment will include, but not be limited to, light stands, vibration tools and concrete finishing fans. The noise level is not expected to exceed that of a lawnmower.

This approval applies only to the request for extended work hours in your email of July 3, 2019. Any significant changes to the project require advance Council notification and approval.

We are requesting staff review and approval for extended work hours for the above referenced project on Monday, July 8, 2019 and Tuesday, July 9, 2019 from 7PM to 10PM.
