Good Afternoon Melanie:

I noted on the continuation of Nutmeg Solar the question was posited about clearing the forest and filling the non-wetland areas that served as a sink for vernal pool species. But the second part of that (my) line of questioning was to inquire as to whether the solar field could be redesigned with that area filled and cleared, taking some of the arrays from the other portions of the site that were steeply graded --or eliminating the most south block of forest clearing--the rectangular area that protrudes southward from the site and would create undesirable edge habitat within a forest block. I think the applicant understood that my line of questioning was not just about clearing and filling that area, but incorporating that area into the solar array area, to create a better overall layout of the site?

Also, Petition 1358 (small cell installation on a wood pole in Darien) will be added to the meeting agenda on Thursday for its 60-day action as the deadline is 2/4/19 and we do not have any other ripe matters beside Petition 1358 to populate the meeting agenda for 1/31/19, so that meeting will be canceled. Due to concerns expressed by the town and an abutting property owner, it appears to be prudent to "set the date for decision" as the 180 day final decision deadline to allow the petitioner and the town/abutter more time to discuss the installation and possibly modify the original proposal.
