RE: **PETITION NO. 1101** - New Cingular Wireless PCS, LLC petition for a declaratory ruling that no Certificate of Environmental Compatibility and Public Need is required to install a stealth rooftop telecommunications tower on the roof of the existing building located at 79 Park Avenue, Danbury, Connecticut.

Directions to 79 Park Avenue, Danbury

From Hartford, New Britain, Enfield, Meriden, Salisbury, Meriden, Stonington, Milford, and Westbrook:

- Take I-84 westbound to Exit 4 in Danbury (Routes 6 and 202 – Lake Avenue).
- At end of exit ramp, turn left onto Lake Avenue.
- Follow Lake Avenue, which will become West Street, approximately 1.1 miles to Division Street (there will be a Citgo gas station on the corner).
- Turn right onto Division Street.
- Turn right at the first traffic light onto Park Avenue (approximately 550 feet).
- 79 Park Avenue will be approximately .3 mile on right.

From Stamford

- Take Route 7 northbound to where it joins I-84 in Danbury.
- Right after Route 7 joins I-84 eastbound, take Exit 4 in Danbury (Routes 6 and 202 – Lake Avenue).
- At end of exit ramp, turn left onto Lake Avenue.
- Follow Lake Avenue, which will become West Street, approximately 1.0 mile to Division Street (there will be a Citgo gas station on the corner).
- Turn right onto Division Street.
- Turn right at the first traffic light onto Park Avenue (approximately 550 feet).
- 79 Park Avenue will be approximately .3 mile on right.

Directions to City Hall from 79 Park Avenue

- Return to West Street.
- At intersection of West and Division Streets, turn right onto West Street.
- From West Street, turn right onto Deer Hill Avenue (look for First Congregational Church – a large red brick building with a tall, white cupola; approximately .2 mile)
- City Hall will be on the left after turning onto Deer Hill Avenue.

Directions to Dinner: at Nico's Pizza & Pasta Restaurant, 175 Main Street

- From City Hall, walk to West Street and turn right.
- Main Street will be two blocks away, approximately 950 feet.
- Danbury Library is on the corner of Main and West Streets.
- Nico's Pizza is across Main Street from the library.
