1. I am a Project Manager for The United Illuminating Company, 180 Marsh Hill Road, Orange, Connecticut (“UI” or the “Company”). I am over the age of eighteen years and understand the obligations of making statements under oath.
2. Pursuant to Section 16-50j-21 of the Regulations of Connecticut State Agencies, UI erected one (1) 4’ x 6’ sign at the entrance to Hawthorne Substation, in Fairfield, Connecticut, the site of a the proposed project. UI installed the sign on March 12, 2015.

The sign reads:

The Connecticut Siting Council (Council) will hold a public hearing on March 31, 2015 beginning at 3 p.m., and continued at 7 p.m., at the Education Center, 2nd Floor Conference Room, 501 Kings Highway East, Fairfield, Connecticut, and thereafter as necessary. The hearing will be on a petition from The United Illuminating Company for a declaratory ruling that no Certificate of Environmental Compatibility and Public Need is required for the proposed modifications to the Hawthorne Substation located at 180 Hawthorne Drive, Fairfield, Connecticut.
