


Dear Siting Council,

Please be advised that we received a letter of incompleteness regarding Petition No. 622A on January 19, 2018. During this time of filing and the subsequent receipt of Notice, we had also received a few calls from the neighbor that directly abuts the subject site. Their concern was regarding the tower location. We submitted a letter to the abutter evidencing the new placement of the tower 22.2ft from original location. The new location is of concern to the abutter in that she believes the tower would now encroach or be directly placed on her property. We immediately notified Eversource and they had a survey conducted. The survey was completed on Monday, the correct tower relocation is 23.9ft. A second revised abutters letter will be going out today to all of the abutters including the underlying property owner. The revised property list and new proof of receipts and tower location will be submitted with the completed interrogatories package.

Please accept this notice of request for an extension of time needed for both the notice of incompleteness and the interrogatories. We ask for the new deadline date of February 16, 2018.

We apologize for the delay with this matter, we needed to address the concern of the abutter and ensure that any necessary corrections were made.
