Algonquin Gas Transmission, LLC ("Algonquin") hereby notifies the Federal Energy Regulatory Commission ("Commission") that Algonquin and Middletown Power LLC ("Middletown") have reached a mutually acceptable resolution regarding the Kleen Energy Lateral route through the Middletown Station property. On February 5, 2009, the Commission issued its "Order Issuing Certificate" in the captioned proceeding authorizing Algonquin to construct, install, own and operate the Kleen Energy Lateral. On March 9, 2009, Middletown filed a Request for Clarification and Rehearing ("Request for Clarification and Rehearing") of the February 5 Order. In its Request for Clarification and Rehearing, Middletown sought a Commission determination that the February 5 Order "requires Algonquin to negotiate a mutually agreeable route through the Middletown Station property." On March 24, 2009, Algonquin filed a Motion for Leave to Answer and Answer in which Algonquin notified the Commission that it would continue to focus its efforts on the negotiations with Middletown but reserved its right to file a supplemental answer in the event that a negotiated resolution could not be attained.

Algonquin and Middletown have now reached a mutually acceptable resolution regarding the route for the Kleen Energy Lateral through the Middletown Station property. The agreed-upon route includes modifications to the certificated route, which will be reflected in alignment sheets to be filed with the Commission. Contemporaneous with this filing, Middletown is submitting a motion to withdraw its Request for Clarification and Rehearing.
