The Connecticut Siting Council (Council) is in receipt of your recent correspondence submitted to Representative Prasad Srinivasan's office concerning above-referenced Petition No. 922.

This Connecticut ratepayer-funded, Class I Renewable Energy project was selected in 2008 by the Connecticut Clean Energy Fund as part of the Project 150 Initiative established by the legislature. The site was selected based on its location within an energy constrained area and the availability of fuel, electrical interconnection, water and land. The project site is located on a 7-acre parcel owned by Connecticut Natural Gas that is improved with an existing natural gas gate station and other related existing utility infrastructure.

Please be advised that the Council received this petition for a declaratory ruling for the installation of the fuel cell facility on November 5, 2009, held a public field review of the project site on November 30, 2009 and rendered a decision on the petition with conditions on December 4, 2009. As required by law, notice of the petition was provided to the Town and abutting property owners on October 16, 2009 and notice of the public field review was provided on November 23, 2009. No comments were received.
