Dear Chairman Stein:

The Connecticut Siting Council (“Council”) approved The Connecticut Light and Power Company’s (“CL&P”) Development and Management (“D&M”) Plan for the North Bloomfield Substation to Connecticut / Massachusetts State Border 345-kV Overhead Transmission Line via a letter sent to me on October 27, 2010. Included in Appendix F of that plan was a “Project Change Approval Process”, and in accordance with that process, CL&P is hereby requesting Council approval of the following D&M Plan changes.

- On February 8, 2011 the Connecticut Siting Council (Council) considered and approved a January 14, 2011 revision to Appendix E, “Drainage Analysis for the Newgate/Phelps Road and Hatchett Hill Road Areas” (Drainage Analysis), of the Development and Management (D&M) Plan. In Section 5.3 of the revised Drainage Analysis, the design of the permanent control has been slightly modified to function within the existing terrain contours and conditions noted in the field. Exhibit A (attached) depicts the location and provides details on the modified control. CL&P has obtained all other permit approvals required for this permanent control.
- The following construction pads and access roads in Suffield will remain in upland areas within the CL&P right-of-way, per landowner requests:
 - three pads and the access road associated with Structures 0087 and 0088
 - five pads associated with Structures 0091, 0092, 0093, 0094 and 0096
 - portions of two pads associated with Structures 0090 and 0095
 - four pads associated with Structures 105, 108, 109 and 110

Pursuant to the Council’s Regulations, the owners of property where these D&M Plan changes would occur are each receiving copies of this filing.
