To Whom It May Concern:

This firm represents Omnipoint Communications, Inc., a subsidiary of T-Mobile USA, Inc. d.b.a. T-Mobile ("T-Mobile"). T-Mobile intends to file an application for a certificate for environmental compatibility and public need (the "Application") with the Connecticut Siting Council (the "Council") regarding certain real property commonly known as 123 Pine Orchard Road, Branford (the "Property"). T-Mobile seeks to construct, maintain and operate a telecommunications facility on the Property.

## PUBLIC NOTICE

Pursuant to General Statutes § 16-50f and § 16-50f-1 of the Regulations of Connecticut State Agencies, notice is hereby given that Omnipoint Communications, Inc., a subsidiary of T-Mobile USA, Inc. d.b.a. T-Mobile ("T-Mobile") will file an application with the Connecticut Siting Council (the "Council"). T-Mobile will file an application for a certificate of environmental compatibility and public need for the construction, maintenance and operation of a wireless communications facility at 123 Pine Orchard Road, Branford, Connecticut (the "Application"). T-Mobile will file the Application on or about August 10, 2009. T-Mobile seeks to construct a new 125 foot, self-supporting monopole tower, with antennae, associated equipment and other site improvements necessary for the proposed facility (the "Facility"). The location, height and other features of the Facility are subject to review and change by the Council pursuant to General Statutes § 16-50g *et seq.*

The Facility will provide wireless service in the Town of Branford, specifically along Pine Orchard Road, Route 146, Damascus Road and Meadow Wood Road and the nearby Amtrak Rail Line as well as in adjacent areas. The Application will set forth the need, purpose and benefits of the Facility and will also describe the environmental impact, if any, of the Facility.

T-Mobile will conduct a balloon float at the proposed height of the Facility on the day of the public hearing on the Application as scheduled by the Council. The Council will provide notice of the public hearing date. The Council will conduct that public hearing in Branford. The balloon float will take place between 1:00p.m. and 6:00p.m. or as set by the Council.
