Dear Attorney Kohler:

At a public meeting of the Connecticut Siting Council (Council) held on December 12, 2013, the Council approved the transfer of the Certificate of Environmental Compatibility and Public Need (Certificate) from Celco Partnership d/b/a Verizon Wireless to Construction Services Towers, LLC (CST). This approval of transfer is consistent with State law and conditioned on the consent of CST to comply with all the terms, limitations, and conditions contained in said Certificate issued on July 29, 2010 and on the timely payment of apportioned assessment charges for the facility under Connecticut General Statute § 16-50v(b)(2).

Furthermore, the Council considered CST's request for an extension of time dated November 22, 2013, and granted an extension of time until August 2, 2014 to complete the construction of this project. Please notify the Council in writing upon completion of construction and site operation.

Pursuant to conditions 8 and 10 of the Certificate, any request for extension to fully construct this telecommunications facility with at least one fully operational wireless telecommunications carrier shall be filed with the Council not later than 60 days prior to the expiration of this Certificate and shall be served on all parties and intervenors, as listed on the current service list and the Town.


Dear Attorney Bachman:

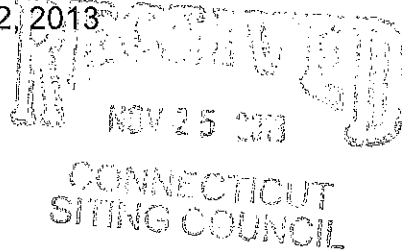


