I thought it might be helpful to the Council members and staff, and to other participants in this Docket, to have an idea of how the Applicant intends to order the presentation of its case.

On June 4, 2012, the Applicant will present a combined panel of Robert E. Carberry, John C. Case, Anthony M. Mele, Louise Mango, and William H. Bailey. Messrs. Carberry, Case and Mele will adopt under oath their pre-filed "Testimony Concerning Engineering, Design, Siting, Construction, and EMF Characteristics of The Connecticut Portion Of The Interstate Reliability Project." Ms. Mango will adopt under oath her pre-filed "Testimony Concerning Environmental Features, Impacts, And Mitigation Measures of the Connecticut Portion of the Interstate Reliability Project." Dr. Bailey will adopt under oath the report he authored entitled: "Current Status of Research of Extremely Low Frequency Electric and Magnetic Fields and Health: Interstate Reliability Project," which is Appendix 7D in Vol. 1 of the Application.

Finally, these witnesses will adopt under oath the Application, with the exception of Vol 1. Sec. 2 (Need); Vol. 1A, Sec. 13.2 (Non Transmission Alternatives); and Vol. 5 and the CEII Appendix (Need).

On June 5, 2012, the panel will be joined by Anthony Johnson of CL&P, who will be available to respond to questions on vegetation management.

I expect that the questioning of these witnesses, and any additional witnesses required to cover specific topics within the general subjects addressed by the pre-filed testimony and report identified above will continue on June 26 and 28. After the questioning of these witnesses has concluded, CL&P will present its witnesses on need and non-transmission alternatives, who will adopt the pre-filed testimony of Timothy F. Laskowski and Roger C. Zaklukiewicz "Concerning The Need for The Interstate Reliability Project;" and the Application sections and responses to discovery requests not previously received into evidence. CL&P may also seek permission to present additional pre-filed testimony on need in light of the results of the ongoing need assessment being performed by the Independent System Operator – New England, the results of which are expected to be available by July 9, 2012.
