DOCKET NO. 466 - The Connecticut Light & Power Company d/b/a Eversource Energy Certificate of Environmental Compatibility and Public Need for the Frost Bridge to Campville 115-kilovolt (kV) electric transmission line project that traverses the municipalities of Watertown, Thomaston, Litchfield, and Harwinton, which consists of (a) construction, maintenance and operation of a new 115-kV overhead electric transmission line entirely within existing Eversource right-of-way and associated facilities extending approximately 10.4 miles between Eversource's existing Frost Bridge Substation in the Town of Watertown and existing Campville Substation in the Town of Harwinton; (b) related modifications to Frost Bridge Substation and Campville Substation; and (c) reconfiguration of a 0.4 mile segment of two existing 115-kV electric transmission lines across the Naugatuck River in the Towns of Litchfield and Harwinton within the same existing right-of-way as the new 115-kV electric transmission

Dear Ms. Taylor:

Pursuant to Regulations of Connecticut State Agencies §16-50j-62 (b) and in response to your email of August 9, 2017, the Connecticut Siting Council (Council) staff hereby approves a change to the Development and Management (D&M) Plan for the above-referenced project to allow administrative work to occur between 6:00 a.m. and 7:00 a.m., Mondays through Fridays and between 7:00 a.m. and 8:00 a.m. on Saturdays at Campville Substation in the Town of Harwinton.

This approval applies only to the additional work hour requested in your email of August 9, 2017. Any additional changes to the D&M Plan require advance notification and approval in accordance with the Council's approval of the D&M Plan on September 15, 2016. Furthermore, the Certificate Holder is responsible for reporting requirements pursuant to Regulations of Connecticut State Agencies § 16-50j-62.

Please be advised that deviations from this plan are enforceable under the provisions of the Connecticut General Statutes § 16-50u.

Proposed Extended Work Hours

Dear Ms. Bachman:



Pursuant to the Connecticut Siting Council's (Council) approval letter for the above Docket's Development and Management (D&M) Plan for the Construction of the Frost Bridge to Campville 115-kV Project (Project) New 115-kV Transmission Line and Related Transmission Line Modifications, dated September 16, 2016, The Connecticut Light and Power Company doing business as Eversource Energy (Eversource) requests that the Connecticut Siting Council (Council) permit the performance of administrative work only at Campville Substation between the hours of 6:00 AM to 7:00 AM, Mondays through Saturdays.

Eversource requests the extended work hours for the ability to conduct administrative work only. Administrative work would be performed by the Project's on-site foremen that utilize the field office located in construction trailers inside the substation fence as their primary work location to support the Campville Substation modifications. This allows the on-site foremen to complete administrative work (such as responding to emails, updating construction progress logs, and reviewing timesheets) prior to the start of construction work, at which time they are responsible for monitoring the safety and performance of construction crews. Up to five Project personnel would be arriving at the substation for the 6:00 am start. All work occurring between the hour of 6:00 am and 7:00 am would be confined within the construction trailers.

Eversource has notified both the Town of Harwinton and abutters regarding the proposed work hour change. Town representatives expressed no concerns about the early commencement of administrative work, provided that construction activities continue to start at 7:00 AM Monday through Friday and at 8:00 AM on Saturday, as previously approved by the Council.
