Dear Ms. Berry:

On November 6, 2007, the Office of Health Care Access (“OHCA”) received your application for the relocation of its obstetrics and gynecology services and pediatric services from 94 Connecticut Boulevard, East Hartford, to 110 Connecticut Boulevard, East Hartford, Connecticut.

Please be advised that OHCA has reviewed the information submitted in your request and makes the following findings:

1. East Hartford Community HealthCare, Inc. (“EHCH or Petitioner”) is a private, non-profit, Federally Qualified Health Center (“FQHC”) located at 94 Connecticut Boulevard, East Hartford, Connecticut.
2. East Hartford Community HealthCare Inc. is proposing to relocate its obstetrics and gynecology services and pediatric services from 94 Connecticut Boulevard, East Hartford, to 110 Connecticut Boulevard, East Hartford, Connecticut.
3. East Hartford Community HealthCare, Inc. receives funds from the Department of Public Health.
4. East Hartford Community HealthCare, Inc. site is located in a designated medically underserved population area.

6. The Petitioner's service area and target population will not change as a result of the relocation.
7. No additional services are proposed and no services will be terminated.
8. The capital expenditure associated with this relocation is \$880,780.

Based on these findings, OHCA has determined that Certificate of Need approval is not required for you to proceed with the relocation of its obstetrics and gynecology services and pediatric services from 94 Connecticut Boulevard, East Hartford, to 110 Connecticut Boulevard, East Hartford, Connecticut.
