CON Exemption Request Pursuant to Section 19a-639b, C.G.S.

Relocation of an Outpatient Psychiatric Clinic for Children in Danbury

Dear Mr. McNellis:

On November 6, 2008, the Office of Health Care Access ("OHCA") received your request for an exemption from the Certificate of Need ("CON") process, pursuant to Section 19a-639b of the Connecticut General Statutes ("C.G.S."), to relocate its outpatient psychiatric clinic for children from 75 West Street in Danbury to 80 West Street in Danbury.

Upon review of the information contained in the request, OHCA finds the following:

- 1. Family and Children's Aid, Inc. ("FCA") is a non-profit facility providing outpatient psychiatric services to children and families at 75 West Street in Danbury, Connecticut.
- 2. FCA is proposing to relocate its outpatient psychiatric clinic for children from 75 West Street in Danbury to 80 West Street in Danbury.
- 3. The Department of Children and Families ("DCF"), in a letter received March 23, 2009, from Commissioner Susan I. Hamilton, JD, MSW endorses the proposal and the waiver of the CON requirements, pursuant to Section 19a-639b, C.G.S.
- 4. DCF states that FCA is a 501-c-3 non-profit corporation headquartered in Danbury, Connecticut that currently provides an array of behavioral health and family support services to children and families throughout Northwestern Connecticut. FCA is the recipient of DCF grant funds for the provision of child guidance clinic services, extended

day treatment, Intensive In-home Child and Adolescent Psychiatric Services, Family Support Teams, and other behavioral health services and supports.

- 5. DCF also states that FCA proposes to provide a full array of outpatient behavioral health evaluation and treatment services including psychiatric consultation and medication management to children and families at the above location.
- 6. DCF states that FCA purchased property across the street at 80 West Street and used a combination of fund raising dollars and state bond funds to renovate the building and FCA plans to use the 2nd floor space to provide outpatient psychiatric services to the same children and families they have been serving at 75 West Street. They will continue to serve children and families from Danbury, Newtown, Redding, Ridgefield, Wilton, New Milford, Bridgewater, Sherman, Brookfield, New Fairfield, and Bethel.
- 7. DCF states that the proposed establishment of new service sites is consistent with DCF's efforts to improve access to needed behavioral health treatment and support services throughout the state and particularly in Northwestern Connecticut.
- 8. The total capital expenditure associated with the proposal is \$1,156,000.

Based on the above findings, OHCA has determined that Family and Children's Aid, Inc.'s request to relocate its outpatient psychiatric clinic for children from 75 West Street in Danbury, to 80 West Street in Danbury, meets the exemption requirements of Section 19a-639b of the Connecticut General Statutes and, therefore, is exempt from OHCA's CON process. Termination of these services would require CON approval, pursuant to Section 19a-638, C.G.S.
