Reinvestment Plan Update

Presented by Brandon L. McGee, Jr., Chief Executive Officer

Key highlights:

• Reaffirmation of SEC's mission and strategic plan.

- Revitalize and Reimagine Program (R2): Focus on economic development, re-entry programs, and youth initiatives in six designated Disproportionately Impacted Areas (DIAs): Bridgeport, Hartford, New Haven, Norwich/New London, Stamford, and Waterbury.
- Funding: \$21.6 million over 3 years (\$7.2 million annually), distributed across the six regions.

Grant Manager RFP:

- Expected release: Mid-June 2025
- o Up to \$120,000 per grant manager
- Nonprofit, Connecticut-based entities with at least 5 years of grant management experience
- Oversight:
 - o Monthly financial and quarterly programmatic reporting required
 - Emphasis on transparency, accountability, and compliance (targeting 100% compliance with reporting)
 - Standardized reporting templates and a centralized portal in development

Questions/Discussion:

- Andrea Hawkins inquired about public access to the RFP guidelines —
 McGee confirmed FAQs will be available on the SEC website.
- Kyle Abercrombie questioned the 95% compliance figure team clarified it will be revised to aim for 100%.

Workforce Development Update

Presented by Brandon L. McGee, Jr., Chief Executive Officer

- Goals:
 - 1. Support for social equity entrepreneurs (e.g., business planning, application assistance, workforce development).
 - 2. Create access to training pathways (e.g., cannabis and trades like HVAC, plumbing).
 - 3. Align efforts with broader equity objectives across sectors.
- Pilot Program: Social Equity Resource Hub



- Designed to address gaps and pain points in support for social equity entrepreneurs.
- Will include free legal, business, and technical services via partnerships with external incubators and service providers.
- o Target launch: End of current fiscal year.
