Call to order and welcome!

Approval of January 11, 2023, Meeting Minutes

Chairman Robertson asked for a motion to approve the minutes from January 11, 2023.

Approval of January 14, 2023, Meeting Minutes

Chairman Robertson asked for a motion to approve the minutes from January 14, 2023.

Motion – by Michael Jefferson Second – by Andrea Comer In Favor – All Abstention – None Motion passed.

Executive Session on Pending Litigation

Chairman Robertson asked for a motion to go into Executive Session.

Motion – by Michael Jefferson Second – by Andrea Comer In Favor – All Abstention – None

Upon returning from Executive Session, the roll was taken again to ensure a quorum.

Vote on Workforce Development Plans

Sarona Saadeh stated that CohnReznick reviewed 3 Workforce Development Plans and 2 were recommended for approval.

Chairman Robertson asked for a motion to accept the recommendation to approve Workforce Development Plan application #ACME008473 submitted by MCEJV, LLC, and ACRE0015647 submitted by FFDW EJV, LLC.

Motion – by Michael Jefferson Second – by Andrea Comer In Favor – All Abstention – None Motion passed.

There was a discussion about the criteria used to approve or deny the Workforce Development Plans.

Councilwoman Vallieres discussed that if a plan received a 70 or above, it would be approved; for less than 70, the applicant would have to make modifications to their plan.



Councilwoman Gordon questioned if an applicant was able to resubmit the Workforce Development Plan after a denial.

Attorney Matrevi responded that the applicant was able to resubmit an updated plan. He also clarified that in this case, the denial was due to the applicant mistakenly uploading only part of the plan and has been addressed with the applicant.

There was further discussion on how applicants are scored.

Chairman Robertson requested a motion to accept the recommendation to reject Workforce Plan application #ACRE0015644 submitted by Budr Hartford Holding, LLC, for an incomplete submission.

Motion – by Michael Jefferson Second – by Ojala Naeem In Favor – All Abstention – None Motion passed.

Vote on Social Equity Plan

Attorney Matrevi recommended the Council approve the Social Equity Plan submitted by FFDW EJV, LLC, for their retail establishment in Manchester.

Councilman Gaddis made a motion to approve the Social Equity Plan submitted by FFDW EJV, LLC.

Motion – by Avery Gaddis Second – by Michael Jefferson In Favor – All Abstention – None Motion passed.

Discussion on Legislative Updates

Kristina Diamond discussed legislative updates. Cannabis bills may be up for a Public Hearing as soon as next week. Staff anticipated testifying in support of the SEC's legislative proposals and recommends testifying in opposition to Senate Bill 203 and Senate Bill 403, which would allow hemp farmers to cultivate recreational cannabis. Regarding changes to the lottery process, House Bill 5432 establishes a graduated schedule of cannabis application fees and House Bill 5730 would allow an individual or business to file only 1 application in the lottery. SEC staff recommends the Council supports the lottery process being more equitable. SEC will also testify at any appropriations budget hearings as necessary. Any official SEC testimony will be provided by Executive Director Clay and Chairman Robertson.





Councilwoman Comer questioned the potential legislation regarding an ombudsman. She also asked if there would be assistance with developing testimony if a council member wished to testify.

Ms. Diamond replied that the bill intended to propose an ombudsman for DCP and dealing with medical patients, not regarding social equity or DECD.

There was discussion on council members testifying. Councilman Jefferson was concerned by council members testifying without having their statements vetted by Staff to ensure consensus.

Councilwoman Vallieres asked how opening the opportunity for hemp farmers to cultivate and sell cannabis would affect the licensing process, lottery process, and the social equity component of what the Council is trying to oversee.

Ms. Diamond explained that the number of hemp growers is sure to increase if hemp farmers are allowed to cultivate recreational cannabis, and the concern is oversupplying issues and diminished retail pricing, undermining the intent of the Cannabis Bill.

Councilwoman Gordon asked if the SEC-supported legislation is being proposed by a specific legislator or going through the chairs of the General Law Committee.

Ms. Diamond understood that the SEC proposals would be submitted as a raised bill in the General Law Committee. Staff will continue to meet with the General Law Committee in helping to move the legislative proposals forward. She also suggested that if individual members are interested in testifying, they submit their testimony to SEC staff and the Chair to make sure that it is vetted.

Executive Director's Report

Executive Director Clay spoke about SEC staffing, program updates, and the focus for February. Staff is working with the Department of Administrative Services to fill 5 Social Equity Council office positions: CD Assistant Administrator, Paralegal, Program Manager for Reinvestment, Program Manager for Outreach, and Administrative Assistant.

In program updates, the Accelerator Program started January 16 and participants have reported learning a great deal. The Canna-Business Revolving Loan Fund Program is being finalized with webinars and information sessions planned as soon as those details are complete. Staff will be going back to the Bond Commission for additional funding based on feedback that a lot of people may be coming to borrow money from this fund. Regarding Community Reinvestment, an ad hoc committee chaired by Ojala Naeem was established. In Workforce Development, Staff continues to work with the Office of Workforce Strategy. Governor Lamont is scheduled to deliver his annual budget address tomorrow February 8. Social Equity Council staff will be reviewing Social Equity Plans submitted by social equity applicants, with 1-point checklist criteria. Each business is required to provide a 6-month progress update to the Council as well as an annual report as a condition of their license renewal. This will be tracked and monitored.



Councilman Jefferson asked who on the staff reviews the Social Equity Plans.

Executive Director Clay responded that she and Attorney Matrevi reviewed the first plan, and she will continue to do so.

Committee Reports

Reinvestment Committee
 Ojala Naeem
 The committee has been established and is working to get a meeting on the calendar
 for the upcoming weeks. The goal is to define and redefine the plan for reinvestment
 and come back to the Council with a proposal in terms of the funds requested for this
 fiscal year and the next fiscal year.

• Finance Committee Andrea Comer
With the departure of Councilwoman Shaw, Councilwoman Comer has returned as
Chair of the Finance Committee. Previously the Finance Committee was meeting
quarterly, and that is being moved to bimonthly because of the conversations around
community reinvestment and the absence of funds. For Fiscal Year '23, there is about
\$6.1M in the Community Reinvestment and Workforce Development line that has
been untouched. The Finance Committee will talk through developing a plan for
reinvestment plan to release those funds for FY '24 and '25 and also hear from the
Reinvestment Committee on suggested plans.

Councilman Jefferson was concerned that the money in that fund is used to give back to the disproportionately impacted communities within the next 6 months.

Councilwoman Gordon stated the Outreach Committee was prepared to listen to the community's needs.
