Discussion - Consolidation of SEC Committees

Executive Director Clay stated that an offer of employment has been extended to a finalist for the Reinvestment Program Manager. That person will be the liaison for the committee. Executive Director Clay further stated that she is currently interviewing for the position of Cannabis Workforce coordinator and that person will also interact with this committee.

5. Reinvestment /Workforce Plan

Executive Director Clay stated that she wanted to have this item on the agenda in the event the council had any questions. We established a pilot program this year which is in full affect. Folks are applying for the six million dollars that has been placed in each of the communities for the end of the last fiscal year and will be receiving those recommendations hopefully, very soon. Executive Director Clay asked if what the committees' thoughts were regarding their respective communities, and the folks committee members represent. Executive Director Clay stated that she

would like the committee to share information with the SEC staff so that they can move some of that information into the reinvestment plan that will be developed through the community conversations.

Executive Director Clay stated that

she believes the money that needs to be spent is approximately twenty million dollars from the special fund that we received through applications and conversion fees and money will be at our disposal July 2024. Our goal is to have the plan completed by May of 2024 and that will give us the opportunity to reach those secondary communities that are still affected by the war on drugs.
