Council Chairwoman Andrea Comer commenced the special meeting in place of Chair Edwin Shirley, who was unavailable. The meeting was called to order at 3:12 p.m.

## 3) Review Bylaws

Chair Andrea Comer confirmed the presence of a quorum and introduced the sole agenda item, the bylaws review. She mentioned the PDF document shared with the committee and proposed either screen sharing for discussion or proceeding with a motion, second, and discussion. Councilman Michael Jefferson suggested moving for unreadiness after the motion and second. Councilman Jefferson then made the motion to approve the bylaws from April 24th's Personnel meeting, which was seconded by Councilman Abercrombie. The discussion highlighted revisions regarding language consistency with statutes, particularly around the Executive Director's role. Councilman Abercrombie suggested removing the section entirely, which Councilman Jefferson agreed to. Chair Comer facilitated the discussion, ensuring a motion amendment to approve the bylaws with the specified removal. Councilman Abercrombie made the amended motion, seconded by Councilman Jefferson, and the bylaws were approved with the removal. The meeting concluded with expressions of gratitude for the committee's work and an invitation to a Juneteenth event in New Haven by Councilman Jefferson.
