INCIDENT LOCATION - ADDRESS OR INTERSECTION AND TOWN

As the registered owner of the vehicle described above, YOU are being issued an INFRACTION TICKET for violating CT motor vehicle law 14-279 pursuant to 14-107. It is understood that the registered owner may not have been operating the vehicle at the time of the incident. However, state law provides that the vehicle owner may be charged with: 'passing a school bus while displaying flashing, red signal lights'. You MUST either pay the fine by the due date shown on the ticket; **OR**, you MUST plead 'not guilty' by the due date shown on the ticket. Please follow the instructions on the reverse side of the ticket. If you do neither, **your driver license may be suspended.**
