This is a sale To a corporation, partnership, or LLC, or To a stockholder, partner or member.

Conn. Gen. Stat. §12-431 provides an exemption from use tax:

- when a motor vehicle or vessel is sold in connection with: the organization, reorganization or liquidation of an incorporated business; or
- when a motor vehicle is sold in connection with the organization or the termination of a partnership or limited liability company.

Note: The exemption for incorporated businesses is for motor vehicles and vessels; the exemption for partnerships and LLCs is for motor vehicles only.

The sale of a motor vehicle or vessel to or from a corporation or the sale of a motor vehicle in connection with the organization or termination of a partnership or LLC may be made without payment of tax, provided that **all** of the following elements are present:

1. For **Corporations**: The vehicle or vessel is sold in connection with the organization, reorganization or liquidation of an incorporated business. For **Partnerships or LLCs**: The vehicle is sold in connection with the organization or termination of a partnership or LLC. Provide the date of action filed with the Secretary of the State.
